As part of our CORE work, we invest in the following CORE Collaboratives—groups of community partners working on shared, structured and measured, long-term solutions for families with young children (prenatal to age 8) throughout Snohomish County.

We are active partners in these Collaboratives, we facilitate learning opportunities and connections between partners, and we advocate for policy changes at the local, state, and federal levels.

When you give to the CORE Fund, you are supporting a new approach to solving poverty. Rather than meeting one need that a child may have today, you are helping whole families find comprehensive, lasting solutions. Invest in something different.

CASINO ROAD ALL FAMILIES ARE READY



All Families Are Ready (AFAR) reduces barriers within and between systems that include healthcare, education, jobs, housing, and nonprofits. They also serve many families in one location in South Everett. Their community hub, The Village on Casino Road, supports these families with adult education, small business development, GED classes and classes for multilingual learners, early childhood education, and afterschool care.

HOMEWARD HOUSE



Homeward House reduces barriers within and between systems that include healthcare, housing, nonprofits, and government. For some families involved in legal dependency cases due to substance, support, social service navigation, and court-ordered visitation are all provided in one, welcoming house. Families are connected to a coordinator and have mentors who've lived through what they're going through.

IMPROVING SCHOOL ATTENDANCE FOR FAMILIES IN TRANSITION



Improving School Attendance (ISA) reduces barriers within and between systems that include healthcare, education, housing, nonprofits, and government. Many families they serve are experiencing homelessness and have children that are chronically absent from Everett School District. School staff are provided professional development, and family advocates working in shelters provide comprehensive support to families.

NORTH COUNTIES' COMMUNITY COLLABORATIVE



North Counties' Community Collaborative (NCCC) reduces barriers within and between systems that include education, healthcare, housing, and nonprofits and serves families in Darrington experiencing poverty. Families in this isolated, rural community have limited services, Internet connectivity, and public transportation. Providers cut down on roadblocks to access local services, and they bring new services right into Darrington.

Working two jobs just to keep a motel roof over me and my kids' heads, and food [on the table] —because I make too much for food stamps—I had too much to handle. And I got told one time that if I was a drug addict or living in a car on the streets, I'd be a better case. [Thanks to the help we received from the Collaborative] I have *so much less stress*.
