## HOW DOES IT WORK?

1

### FAMILIES AND INDIVIDUALS—WALK-IN, IN-PERSON TAX PREP

Walk into a tax site and inquire about open time slots for in-person filing. First come, first served basis with no guarantee of availability. Wait times will vary.

### FAMILIES ONLY—DROP-OFF TAX PREP

Drop off tax information, sign forms, and pick up completed taxes one week later. No appointment necessary. Wait times will vary. Only available at Edmonds Community College in Lynnwood, on Mondays at St. Vincent de Paul in Monroe, or on Saturdays at Hand in Hand in Everett.

### FAMILIES ONLY—IN-PERSON TAX PREP WITH APPOINTMENT

Make an online appointment (open now!) on a first come, first served basis. Appointments are for in-person filing only. Expect up to 1 hour to complete taxes on-site. Visit [www.uwsc.org/taxhelp](http://www.uwsc.org/taxhelp) to schedule.

## TRAINED, FAST, FREE



### TRAINED

Certified by the IRS, our volunteers go through rigorous training and extensive testing to make sure tax returns are prepared correctly and are submitted securely.



### FAST

Tax returns are filed electronically, ensuring quick turnaround times for receiving refunds, if eligible, and at no cost.



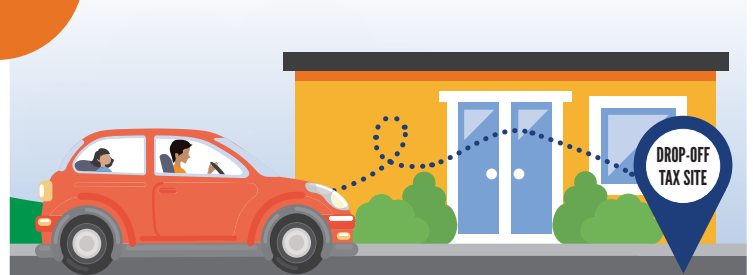
### FREE

## ELIGIBILITY REQUIREMENTS

- Household income of \$55,000 a year or less
- No rental income, no military income, and no business losses
- Business expenses totaling less than \$25,000 in 2018

Our Free Tax Prep Program focuses on making sure families access the Earned Income Tax Credit (EITC), Child Tax Credit, and other credits important to young children and their families with low income.

### SPOUSE

If filing jointly, *both* filer and spouse must be present

### PHOTO IDs FOR TAXPAYER & SPOUSE

Must be government-issued

### SOCIAL SECURITY CARDS OR ITIN NUMBERS

For every person listed on your return

### ALL TAX FORMS

(W-2s, 1098s, 1099s, etc.)

### COPY OF LAST YEAR'S RETURN

### BANK ACCOUNT & ROUTING NUMBERS

For direct deposit
